### *Confidentiality:*


Each party agrees that it shall not, at any time, after executing the activities of this MoU, disclose any information in relation to these activities.

### *Termination of MoU:*

In the event of non-compliance or breach by one of the parties of the obligations binding up or it, the other party may terminate the agreement with immediate effect.

The term and provisions in this MoU also apply to any subsequent Addendum to this agreement.




