(For those admitted in June 2017 and later)

The Rules and Regulations governing the B.A Degree Course in History are to be followed as per the Operational Guidelines for Under Graduate degree courses (for those who admitted in June 2017 and later)

I. COURSE OBJECTIVES

To enable the Students to

- i. Know the detailed study of History of India and Tamil Nadu as well as the substantial surveys of the History of other countries of the world.
- ii. Relate the study of History with practical needs and tasks and equip students with the capabilities to think, comprehend and present issues in the proper perspective.
- iii. Inculcate in sudents a broad inter-disciplinary perspective and thereby make them inquisitive and intellectually sharper.
- iv. Teach students who are eager to study History and acquire a broad understanding of historical ideas, social, economical, cultural and religious developments and popular movements.

II. ELIGIBILITY FOR ADMISSION

Candidates seeking admission into the B.A. HISTORY Degree Course must have passed the Higher Secondary Examination, conducted by the Board of Higher Secondary Examinations, Government of Tamil Nadu or any other examination accepted by the Syndicate of the Madurai Kamaraj University as its equivalent with.

III. DURATION OF THE COURSE

The Course is for a period of three years. There will be two semesters in an academic year.

The number of Tamil and English language courses are 4 in number.

PART III

The number of core courses will be 14. Elective subjects will be 2 and Allied subjects will be 4. Modern Governments (two courses) and General Economics (two courses) will be the Allied Subjects.

PART IV

The number of Non-Major Elective Courses will be 2 and the Skill based Subjects will be 6. A Student has to choose any two of the Non-Major Elective courses offered by other departments. Environmental Studies and Value Education will be the Common Papers in fifth and sixth semester respectively.

PART V

A Student shall be awarded a maximum of 1 credit for compulsory Extension Service. These should be carried out outside the class hours. All the Students shall have to enroll for NSS/NCC/Sports and Games or any other service organizations in the College and shall have to earn minimum hours of attendance to be prescribed by the College.

CREDIT

The term 'Credit' refers to the weightage given to a course, usually in relation to the instructional hours assigned to it. The total Credit required for completing B.A. (History) Degree is 150. The particulars of Credit for individual components and courses are presented in Table 1.
