PURPOSE OF MOU

In particular, this MOU is intended to

1. Provide internships and for students
2. Organize various workshops on Entrepreneurship Development
3. Conduct practical trainings on Entrepreneurship Development
4. Generate self-employment opportunities

LAMP(Linux, Apache, MySQL and PHP) is one of the most powerful and popular open source web application stack. Although setting up a development environment and building application can be done by anyone of limited knowledge in LAMP. A great deal of expertise is needed to tweak and design the application specifically to get the maximum performance from the stack.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause 1

CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

Clause 2

SCOPE OF THE MOU
