MEMORANDUM OF UNDERSTANDING  
BETWEEN

ARTZ TRUST  
AND  
DEPARTMENT OF PHYSICAL EDUCATION  
GTN ARTS COLLEGE, DINDIGUL

FOR THE ESTABLISHMENT OF AN ACADEMY AT DEPARTMENT OF PHYSICAL  
EDUCATION GTN ARTS COLLEGE, DINDIGUL DISTRICT,  
TAMIL NADU FOR THE PROMOTION AND ADVANCEMENT OF SPORTS

This Memorandum of Understanding (hereinafter referred to as the "MOU") is entered  
into at Dindigul on this 18<sup>th</sup> day of December 2020.



**BY AND BETWEEN**

1. **Artz Trust**, a Registered Trust -Act 1882, having its registered office at 2/854, Krishna House, Moovendar Nagar, Seelapadi, Trichy Bypass, Dindigul-624005, Tamilnadu, through its authorized representative **Mrs. Amutha Meenakshi** authorized vide board resolution (hereinafter referred to as "**Trust**", which expression unless repugnant to the context, shall be deemed to include its successors administrators and/or assigns), of the **FIRST PART**

**AND**

2. **DEPARTMENT OF PHYSICAL EDUCATION GTN ARTS COLLEGE, GTN** Nagar, Karur, Road Dindigul – 624005, through its authorized representative (hereinafter referred to as "**GTN Arts College**", which expression shall and where the context admits, include their successors or assigns) of the **SECOND PART**;

The **Artz Trust** and **Department of Physical Education GTN Arts college** shall hereinafter collectively be referred to as "**Parties**" and individually as a "**Party**".

**WHEREAS:**

- A. The Artz Trust is engaged in development of football players and the team by the name Artz Trust-Soccer School that participates in the AIFF- Baby League, a football league And All India matches of repute in India, and is desirous of promoting the game of football in India through grassroots development of the sport.
- B. GTN Arts College is a of reputed educational institution in Dindigul district, Tamil Nadu.
- C. The **Artz Trust** and **Department of Physical Education GTN Arts college** are desirous of entering into this MOU for establishing and running an academy by the name Artz Trust Soccer School (Grassroots) - Academy' ("**Academy**") for creating a Centre Of Excellence (**COE**) of Artz Trust at GTN Arts College and grassroots & Youth development of the sport of football.

**OBLIGATIONS AND RESPONSIBILITIES**

**1. Obligations of the ARTZ TRUST:**

- a. The Artz Trust shall be responsible for providing all technical support (skills, know-how and tactics relating to football) to GTN Arts College existing football team. Upon the establishment of the Academy and COE, all technical support shall also be provided by the Artz Trust to the football team(s) chosen from the Academy.
- b. The Artz Trust shall be responsible for taking all decisions in respect of the existing football team of Department of physical Education GTN Arts College and the future football team(s) formed from the Academy, including the number of such teams in the Academy, selection of students as players in such teams, participation in various tournaments by such football teams.
- c. The Artz Trust shall be responsible for the development of the Academy related Programs and plans, in consultation with GTN Arts college



**2. Obligations of Department of Physical Education GTN ARTS COLLEGE**

- a. Department of Physical Education GTN ARTS COLLEGE shall be responsible for the admission of students in the College
- b. Department of Physical Education GTN Arts college shall be responsible for providing the infrastructure support, i.e. football ground, changing facilities, maintenance of the ground etc., to the Artz Trust for the proper functioning of the Academy and maintaining the standards of a COE of Artz Trust

**PROGRAMMES:**

1. Regular Program (which shall be run at the Academy for the college students)
2. Summer Camp
3. Residential Camp
4. Soccer school training.

**ANNEXURE C**

**CONSIDERATION**

1. The Artz Trust shall be responsible for the collection of all fees/income/amounts generated in respect of Artz Trust - Soccer school.

**TERM:**

This MOU shall be effective from the date of signature of both Parties and shall continue to be in force and binding on the Parties for a period of five (5) years ("Term"),

**TERMINATION:**

Each Party shall have the right to terminate this MOU by giving ninety (90) days prior written notice to the other Party, for the following reasons:

**Governing Law and Jurisdiction:**

If any dispute arises between the Parties hereto during the subsistence of this MOU or thereafter, in connection with the validity, interpretation, implementation or alleged breach of any provision of this MOU or regarding any question, including the question as to whether the termination of this MOU by one Party hereto has been legitimate, the Parties hereto shall endeavor to settle such dispute amicably. The attempt to bring about an amicable settlement shall be considered to have failed as soon as one of the Parties hereto, after reasonable attempts, which shall continue for not less than 30 (thirty) days, gives 30 (thirty) days' notice thereof to the other Party in writing to this effect.

The terms and conditions of this MOU shall be governed by laws of India and the Courts in Dindigul shall have exclusive jurisdiction to settle any dispute which may arise between the Parties with respect to this MOU.




1.1. Further Agreements:
